BREEDING CONTRACT

Transported Chilled Fresh Semen or AI

The following agreement is made between **Steve and/or Sarah Dickmeyer**, hereafter called the Stallion Owner, and _____ who resides at _____, hereafter called the Mare Owner.

The Stallion Owner does hereby agree to breed the purebred Section A Welsh Mountain Pony stallion, ***WHARLEY MAGIC FLUTE, WPCSA #A-40793, A.I. Permit # 285**, hereafter called the Stallion, to the purebred Welsh mare _____, hereafter called the Mare, Registration number _____ Age _____ Color _____, for and in consideration of, the mutual covenants described below.

1. **The stud fee is \$500.00.**
2. **A booking fee of \$50.00 per mare is required for acceptance of this contract**, which will apply to the stud fee. It is non-refundable if the mare owner decides not to breed the mare. It may be transferred to another mare in the same year pending the approval of the mare by the stallion owner. **The remaining stud fee of \$450.00 must be paid in full prior to the first shipment of semen.**
3. The cost of each collection and shipment of cooled semen is the responsibility of the Mare Owner and **must be paid in full prior to the collection of semen.** Collection & shipment is **\$200.00.**
4. Semen will be shipped in a disposable cooled semen shipping container, the Clipper made by Equitainer. The mare owner does not need to return the shipping container.
5. **Limited Live Foal guarantee:** If the mare fails to conceive, the Mare Owner may breed the same mare the following year, for that year's collection and shipping costs. If a mare does not conceive within two breeding years, maximum of six shipments in total, the total stud fee is again payable in full before resuming semen shipments. If a mare fails to conceive, a different mare may be substituted for the second breeding year. **Once a mare conceives, if the resulting foal is stillborn or dies before standing and**

nursing, the Mare Owner will be entitled to the return of the stud fee less the booking fee. This guarantee will apply only if notification of the foal's death plus the breeding certificate issued by the Stallion Owner is sent to the Stallion Owner by registered mail within 48 hours of the foal's death. Statements by a licensed veterinarian of the details of the foal's death must follow within 10 days or the Limited Live Foal Guarantee becomes null and void.

6. The Mare Owner will be issued a valid breeding certificate for the WPCSA by the Stallion Owner when the mare is checked in foal, all paperwork has been returned, and all fees and/or expenses have been paid. A replacement fee of \$25.00 will be charged if the Mare Owner loses a breeding certificate.
